Sealed bids from licensed contractors will be received by Durham Public Schools, Durham, North Carolina on **Tuesday September 17th 2024** for furnishing of labor, material and equipment for the **Fire Alarm Replacement for Githens Middle School, located at 4800 Old Chapel Hill Rd., Durham, NC 27707**. Bids will be received up to **2:00 PM** from Single Prime bidders at which time and place all bids will be publicly opened and read aloud. Deliver bids to the **Durham Public Schools Central Office located at 511 Cleveland Street, Durham, North Carolina 27702.**

- No bid may be withdrawn after the scheduled closing time for the receipt of bids for a period of sixty (60) days.
- Bid security required is 5% of the bid in cash, certified check, or Bid Bond.
- Performance and Payment Bonds for 100% of the contract amount will be required.
- Durham Public Schools reserves the right to reject any and all bids and to waive informalities or irregularities.

Minority Business Participation: Bidders shall note that compliance with County of Durham MBE policies and the North Carolina Statute 143-128.2 (c) are required for this project.

Project scope: This project includes a complete, turn-key Fire Alarm System Replacement at Githens Middle School. The new system will be completely installed, inspected, tested and accepted before the old system is demolished. The new system will be an addressable, voice annunciated system.

Pre-Bid Conference: A mandatory pre-bid meeting will take place at the project site on, **Monday, August 12th, 2024 at 9:00 AM**. The project engineer will be available to discuss the project and answer questions. A tour of the of site will take place immediately after the Pre-Bid Conference. **It is MANDATORY that prime bidders attend the entire Pre-Bid Conference and visit the site prior to bidding.** Participants will be required to sign in at the Main Office(s) since the meeting will occur during school hours.

Statement of Qualifications: Each proposal shall be accompanied by a statement of qualifications that demonstrates experience in at least five (5) projects of similar scope within the past three (3) years with references.

Statement of ability to staff project. Each proposal shall be accompanied by a statement of ability to staff including current project load, current staff levels and individual staff to be committed to this project if awarded.
