Sealed bids from licensed contractors will be received by Durham Public Schools, Durham, North Carolina on **Tuesday, May 21, 2019** for furnishing of labor, material, and equipment for the Northern High School Track Renovation. Bids will be received up to **3:00 PM** from Single Prime bidders at which time and place all bids will be publicly opened and read aloud. Deliver bids to the **Durham Public Schools Construction and Capital Planning Office located at 2011 Hamlin Road, Durham, North Carolina 27704.**

- No bid may be withdrawn after the scheduled closing time for the receipt of bids for a period of sixty (60) days.
- Bid security required is 5% of the bid in cash, certified check, or Bid Bond.
- Performance and Payment Bonds for 100% of the contract amount will be required.
- Durham Public Schools reserves the right to reject any and all bids and to waive informalities or irregularities.

Minority Business Participation: Bidders shall note that compliance with County of Durham MBE policies and the North Carolina Statute 143-128.2 (c) are required for this project.

Iran Divestment Act: Bidders shall note that the submission of a bid constitutes the bidder's certification to the State Treasurer that, as of the date of bid, it is not listed on the Final Divestment List created and maintained by the North Carolina Department of State Treasurer (the "Treasurer's Office") pursuant to the Iran Divestment Act of 2015, Chapter 147-Article 6E of the General Statutes of North Carolina (the "Iran Divestment Act").

Project scope: Remove existing rubberized latex track surface from 7-lane track, triple/long jump runway and pole vault runway. Install new rubberized latex track surface on existing asphalt 7-lane track, triple/long jump runway and pole vault runway. Remove and replace concrete shotput launch pad and pole vault landing pad area. Install dry wells and concrete collars at existing drain inlets for drainage improvements and other related improvements along with all work normal, necessary and usual in the construction of such improvements.
