

## **STUDENT PARKING GUIDELINES/REGULATIONS**

Please return the fully completed application with a photocopy of your driver's license to the Main Office. \*\*\*WE DO NOT MAKE COPIES\*\*\*

Payments can be made **online only** July 21 - August 10, 2017. The cost is \$75.00.

1. The Durham Public Schools Board of Education established the fee of \$75. School rules and school board policies apply to behavior in the parking lot inside and outside vehicles. **Please remember parking a vehicle on school property is a privilege, not a right.**
2. Parking permits will only be sold to the students who possess a valid North Carolina driver's license. Students may not sell, transfer, or purchase parking permits/stickers from other students. Students may be disciplined for any illegal use of parking sticker/permits.
3. All students parking a motor vehicle on the school campus must display the current parking permit tag. Failure to display the parking permit tag properly at all times during the school day may result in consequences, including loss of the parking privilege.
4. Vehicles must be parked in assigned areas. The only spaces available for student parking is in the student parking lot. Students may not park on the road, in staff or visitor parking areas, in any driveway, in hospital/stadium lot or in any other place. If you park illegally, your car may be locked/blocked, towed and/or and you may be fined. Your student parking privileges may also be temporarily or permanently revoked. Criminal charges may also be imposed as prescribed by law. Students may also be subject to school disciplinary action.
5. The safe operation of motor vehicles is required. Speeding and reckless driving are prohibited and may result in the loss of parking privileges.
6. Supervision is provided for parking lots. However, the school system is not responsible for damages or theft to parked vehicles.
7. Student vehicles are subject to a search if there is a reasonable suspicion to believe that drugs, alcohol, stolen property, or other contraband is present in the vehicle.
8. Parking fees will NOT be refunded for:
  - i. Voluntary withdrawal from school
  - ii. Long term suspensions from school
  - iii. School based disciplinary action related to loss of parking privilege
  - iv. Loss of driving privilege due to revocation of driver's license
  - v. Graduation
9. Only one parking space will be issued per student.
10. Lost, damaged, or replacement stickers will be issued for an additional cost.
11. Loitering in any parking lot is prohibited.
12. Please do not park across the street. We have been told by DRH that they will tow all cars without proper parking decals.
